Student Volunteer Contract

Rules and Regulations during Tutoring Sessions

1. SELF RESPECT: All volunteer tutors will provide their best efforts during every tutoring session.
 2. RESPECT OTHERS: All volunteer tutors will treat students with kindness, honesty, acceptance and tolerance
 3. Volunteers are to arrive 30 minutes prior to each tutoring session and be prepared to work immediately. Students are not to be released early before the tutoring session ends.
 4. TUTOR CANCELLATION: Tutors must notify Scheduling Staff at least 24 hours prior to a cancellation of a tutoring session. Failure to show up for a tutoring session or showing up more than 20 minutes late to a session is considered a No-Show. Two No-Shows by a volunteer may result in being terminated as a tutor.
 5. Volunteer tutors are not permitted to engage in private tutoring with any participating student.
 6. Volunteer tutors will not disrupt the learning process of others.
 7. All tutors are responsible for their own teaching materials – including pens, pencils, paper, and files.
 8. There is no eating, drinking, or chewing gum during tutoring sessions.
 9. There is no use of profanity and no personal conversations during tutoring sessions.
 10. The use of cell phones or electronic equipment is not permitted during tutoring sessions.
 11. The exchange of personal contact information between a tutor and a student is not permitted.
 12. All tutors must wear appropriate attire as a tutor and dress conservatively.
 13. Tutors must be respectful to volunteering adults who supervise the tutoring sessions.
 14. Any type of misconduct, including bullying or harassment of any other persons, may result in termination of volunteering services.
 15. After 2 warnings of the violations of rules, YLOC has a right to terminate your membership.

The undersigned understand that this release discharges YLOC from any liability or claim that the undersigned may have against YLOC with respect to any bodily injury, personal injury, illness, death, or property damage that may result from my activities with YLOC, whether caused by the negligence of YLOC or its officers, directors, employees, or agents or otherwise. The undersigned also understand that YLOC does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.
